- How safe is your school's data?
- Does your school have an up to date Data Security Policy?
- Does your Data Security Policy include provisions for homeworking/anytime/ anywhere/access?
- Do <u>all</u> your school's network users (including pupils/students) regularly receive Data Security and Data Protection training?
- Would you know if your school experienced a Data Security Incident?
- How resilient is your school's IT network?
- Is your school's network protected from internal and external threats?

### Did you know?

- It is possible to access inappropriate websites through Playstation and Xbox consoles?
- Different games consoles are best suited to different ages (Nintendo 3DS and Wii U have more games suitable for younger children)
- Many games feature online multiplayer gameplay (competing against or with other players over the internet)
- Games consoles do have parental controls
- Games consoles require an internet connection to download updates. Some remain connected in stand-by mode and download content when not in use (Turn them off when not in use)
- Games consoles connect to online app or games stores which can be used to download games

Research on behalf of the Headmasters' and Headmistresses' Conference (HMC) by the online safety organisation *Digital Awareness UK (DAUK)* finds anecdotal evidence of

## children as young as nine checking devices 10 times a night.
